As part of its Colorado 100k Lives Campaign, The Trust is highlighting participating hospitals and their commitment to improving health care across Colorado through a statewide public awareness campaign.

Beginning with the maxim "Some is not a number, soon is not a time," Donald Berwick, MD, President & CEO of the Institute for Healthcare Improvement (IHI), delivered a detailed progress report on the 100k Lives Campaign at a Learning Lunch hosted by The Colorado Trust in June.

"A total of 3,103 hospitals have enrolled in this campaign to improve the quality of health care in hospitals," he said of IHI's nationwide effort. "That's over 75% of all U.S. hospital beds, which translates to a strong foundation for an effective change network."

IHI launched the campaign in December 2004 with the goal of reducing unnecessary hospital

deaths by 100,000 over an 18-month period by instituting six proven health care interventions in hospitals across the country.

"The mortality data we received from participating hospitals so far has allowed us to estimate that the campaign has resulted in 122,300 saved lives," said Dr. Berwick. "That's very, very good news because it indicates tremendous collaboration and commitment in health care communities to make significant changes in patient care in a short period of time."

As part of IHI's nationwide effort, The Colorado Trust's \$3.8 million, 18-month Colorado 100k Lives Campaign – launched in August 2005 – is helping Colorado hospitals to strengthen their quality improvement systems to ensure safe patient care. The Colorado Foundation for Medical Care is also receiving support from The Trust to coordinate the quality improvement efforts of the 62 participating hospitals statewide. # TRUST ANNOUNCES NEW HEALTHY AGING INITIATIVE

Among today's most pronounced demographic trends is the tremendous increase of the aging population. Indeed, according to a recent report issued by the U.S. Department of Health and Human Services National Institute of Health and National Institute on Aging, it is expected that the older population in the United States will double in size from 36 million in 2003 to over 72 million by 2030, an increase from 12% to 20% of the total population.

In response, The Colorado Trust's Board of Trustees has approved a four-year (2006-2010), \$6.5 million Healthy Aging Initiative. This initiative will provide support through community grantees to senior-serving organizations to strengthen and increase their ability to provide services to today's seniors (ages 65+).

The Trust is currently accepting proposals for a statewide coordinating agency to provide day-to-day management and technical assistance to community grantees under this initiative. All applicants must respond to a Request for Proposals by noon on Friday, August 25, 2006.

After a coordinating agency has been selected, The Colorado Trust will request proposals from senior-serving organizations interested in expanding their organizational capacity. Up to 20 community grants will be awarded. Grantees will focus their efforts on one or more of the following areas:

- Providing information and referral services
- The availability of support services
- Strengthening caregiver support services
- Addressing residential needs
- Promoting healthy lifestyles and wellness.

### TRUST EXPANDS ITS IMMIGRANT INTEGRATION INITIATIVE

In a new phase of its Supporting Immigrant and Refugee Families Initiative, The Colorado Trust will commit an additional \$3 million to help support more Colorado communities in their efforts to strengthen immigrant integration. All told, The Trust's Supporting Immigrant and Refugee Families Initiative, which began in 2000, is a 10-year, \$16.7 million grantmaking initiative and is the first such effort in the nation to provide support to multiple communities across one state.

Up to five communities will be selected to participate under this new funding opportunity. Each will be awarded an initial \$10,000 planning grant to develop comprehensive immigrant integration action plans. Following the planning process, the communities will be invited to submit their plans to The Trust for implementation grants of up to \$75,000 per year for four years.

The 10 communities that are already participating in this initiative are: Aspen to Parachute region, Boulder County, El Paso County, Gunnison County, Lake County, City of Littleton, Mesa County, Morgan County, Pueblo County and Summit County. Each of these communities brought together broad coalitions to participate in an initial planning process, including health care providers, educators, business people, law enforcement, libraries, local government, faith-based organizations, immigrant-serving organizations and immigrants themselves. With their planning process now complete, these communities are beginning to put strategies into place, including integration resource centers, community dialogues and interpreter banks.

Nonprofit and governmental agencies interested in applying for this funding opportunity should review requirements for submitting Letters of Intent. Letters are due to The Trust by August 18, 2006 and new grantees will be announced in late fall 2006. ## OBESITY PREVENTION GRANT JUMPSTARTS INNOVATIVE EFFORT

Realizing that obese employees have higher health care costs, it stands to reason that corporations are increasingly choosing to locate in cities that have low obesity rates. While Colorado currently boasts the lowest obesity rate in the country, experts acknowledge that Coloradans are gaining weight at the same rate as others across the country.

In response, the Metro Denver Health & Wellness Commission is bringing together 33 metro-area mayors to work with fitness experts to develop a plan to help make – and keep – people living in the Denver metro-area fit and healthy.

A \$40,000 grant from The Colorado Trust – a component of its Colorado Healthy People 2010 Initiative – is helping to turn this idea into reality. The new Commission, developed by the Metro Denver Economic Development Corporation as an economic incentive, will develop a 10-year strategic plan with components that can be implemented by employers, schools and communities. 




### TRUST HOSTS HEALTH DISPARITIES LEARNING LUNCH

The Colorado Trust's July Learning Lunch featured nationally renowned health disparities expert Dr. Thomas LaVeist, Director of the Center for Health Disparities Solutions, and Professor of Health Policy and Management at the Johns Hopkins Bloomberg School of Public Health.

Numerous studies show that racial and ethnic health disparities continue to exist throughout the health care system. The Colorado Trust's seven-year (2005-2012), \$13.1 million Equality in Health Initiative seeks to significantly strengthen efforts underway in Colorado to reverse this trend. Under this effort, nonprofit organizations and educational institutions across the state are working to bring about improvements in equality in treatment in medical services, equal access to care, equal environmental conditions, and/or healthy behaviors among racial and ethnic minorities. The Tri-County Health Department, a grantee of The Trust's Colorado Healthy People 2010 and Partnerships for Health initiatives, is the recipient of the National Association of County and City Health Officials' (NACCHO) 2006 Model Practices competition that recognizes innovative work between local health departments and communities to address public health issues.

Specifically, the Tri-County Health Department was named one of 18 model practices nationwide – out of nearly 100 submissions – for its efforts as coordinating agency for The Trust's Healthy People 2010 objective of injury prevention in Metro Denver.

NACCHO, representing the nation's approximately 3,000 local health departments, works to protect and improve the health of all people by promoting national policy, developing resources and programs, seeking health equity, and supporting effective local public health practice and systems.








### COLORADO MUNICIPAL LEAGUE AND THE TRUST TEAM UP ON IMMIGRANT INTEGRATION

The Colorado Trust and the Colorado Municipal League (CML) co-hosted "The Changing Face of Colorado" event on July 21st. More than 40 city and municipal leaders joined together to learn about the skills and knowledge needed to work within the changing demographics of Colorado.

Additionally, a jointly produced brochure, *The Role of Municipal Leaders in Helping Immigrants Become an Integral Part of Colorado's Communities*, was released at the event. The brochure outlines ways that municipal leaders can help to proactively integrate immigrants into Colorado communities, as well as lessons learned in doing so in some communities.

This collaborative effort has been highlighted nationally by the National League of Cities as an example of helping city officials to "build a nation of inclusive communities" through its Inclusive Communities Campaign.
