WORKPLACE WELLNESS: FOOD BANK FOR LARIMER COUNTY

Vern Stockbridge is easily the most active presence at the Food Bank for Larimer County in Fort Collins. As Warehouse Manager, he directs efforts to sort, organize and pack trucks with more than five million pounds of food for those in need each year.

When the 58-year-old was fitted with a pedometer to count his steps, he discovered that he was taking more than 20,000 steps a day – over 10 miles! Measuring Stockbridge's daily physical activity was part of the food bank's commitment to its workers' health and well-being through the Health District on the Move's workplace wellness program. The food bank, along with more than 225 companies and 5,000 employees in Northern Larimer County, as well as other employers, communities and individuals across the state, worked to improve diet and activity levels under The Colorado Trust's Colorado Healthy People 2010 Initiative.

Stockbridge was a natural model for his co-workers. He knew his overall fitness had improved when he began lifting, stacking and directing the movement of parcels at the food bank's warehouse 10 years ago. The former real estate salesman and property manager lost 20 pounds after just six months on the job – his participation in Health District on the Move confirmed his progress.

"It let me know what I was doing," he said. "It made me aware of how much physical activity I was getting, working in a warehouse."

Indeed, according to Chuck Gill, Assistant Director of the food bank, quantifying results and sharing progress are what got employees moving. The goal for employees was to increase the number of steps they took daily by 10% each week to reach 10,000 per day. "Some people saw measurable improvements," he said. "And, as they did more, they felt better."

An **evaluation** of the Colorado Healthy People 2010 Initiative was completed in 2007. Conducted by the National Research Center, the four-and-a-half year longitudinal study measured the effectiveness of obesity prevention and increased physical activity work conducted by grantees in the northwestern and southeastern regions of Colorado. Dietary and physical activity behavior change over time was evaluated, and individual, programmatic and community characteristics that contribute to sustainable behavior change were identified.



Many people do this work because they have lost loved ones to suicide, while others bring mental health expertise or a passion to help their community. Over the past five years, we have had the opportunity to support the suicide prevention work of many of these individuals. Collectively, we have reached out to people in 31 Colorado counties to increase awareness of the problem, reduce stigmas and provide improved access to effective prevention programs.

Now we have an important opportunity to coordinate, consolidate and link these multiple efforts. Colorado's new mental health care champion, First

Lady Jeannie Ritter, has been named Honorary Chairperson of the Colorado Suicide Prevention & Intervention Plan. With Trust support, Mrs. Ritter and **Mental Health America of Colorado** will receive input from experts and residents statewide to develop a comprehensive statewide prevention plan that will both recommend ways to strengthen existing work and build the case for increased mental health and suicide prevention support.



As this planning effort begins, work is also underway to update The Trust's 2002 report, *Suicide in Colorado* – one of our most-requested resources. We look forward to once again sharing current information to further help those dedicated to addressing the problem of suicide in our state.

NEW SUICIDE PREVENTION EFFORTS UNDERWAY

FIRST LADY RITTER CHAIRS STATEWIDE PLANNING EFFORT

The Colorado Trust awarded \$75,000 dollars to **Mental Health America of Colorado** (MHAC) to oversee the Colorado Suicide Prevention & Intervention Plan, a coordinated approach to suicide prevention, education and awareness across the state. The program will incorporate the participation of many partners dedicated to preventing suicide and who aim to reduce Colorado's suicide rate, which is 7th highest in the nation. Colorado First Lady Jeannie Ritter has been named Honorary Chairperson of the planning committee. She will work with MHAC, The Trust and other partners to gather statewide input and help implement successful suicide prevention strategies.


"I'm very proud to be a part of the combined efforts of The Colorado Trust and MHAC to demonstrate that depression is treatable, and that there are avenues for intervention," said Mrs. Ritter. "We are determined to ensure that people know how to ask for help for themselves or someone they care about."

CHALLENGE GRANTS AWARDED

Additionally, The Trust has awarded challenge grants to 10 communities to continue their suicide prevention work. Each of the grantees will receive up to \$20,000 a year for three years from The Trust.

Over the last four years, the grantees have accomplished a range of successes toward suicide prevention, including gatekeeper trainings conducted by Project Hope in southeastern Colorado, counseling and therapy for minority youth in Jefferson County, direct outreach to local Hispanic communities through Spanish-language brochures and other resources, and cross-cultural training of Hispanic community leaders.

SAFE2TELL SELECTED AS FIRST LEADERSHIP AWARD RECIPIENT



Susan Payne, Executive Director of Safe2Tell, was presented The Trust's first John R. Moran Grantee Leadership Award. Safe2Tell gives students in all Colorado schools an increased ability to both prevent and report violence by making anonymous calls to 1-877-542-SAFE. The Colorado Trust's first annual John R. Moran, Jr. Grantee Leadership Award was awarded to the Safe2Tell program. Safe2Tell – developed in response to recommendations from the Columbine Commission's report and The Trust's Safe Communities~Safe Schools Initiative – provides students in all Colorado schools an increased ability to both prevent and report violence by making anonymous calls to 1-877-542-SAFE. The \$25,000 award – created in honor of The Trust's former, long-time CEO – recognizes exemplary leadership by a current Trust grantee.

In presenting the award to Susan Payne, Executive Director of Safe2Tell, Irene M. Ibarra, President and CEO of The Colorado Trust noted that "The Safe2Tell program offers hope to individuals and communities at a time when the escalation of school and campus violence seems overwhelming. Not only has this small, but powerful organization averted and resolved numerous violent situations across Colorado, school administrators and law enforcement officials in over a dozen other states also are looking at how to replicate early successes of the Safe2Tell program."

The presentation was made during a ceremony at the State Capitol on May 3 when Governor Bill Ritter signed into law Senate Bill 07-197, which guarantees the anonymity of callers to the Safe2Tell Hotline. Anonymity is one of the key features of the hotline as young people often don't share information for fear of retribution.

The Colorado Trust first funded the development and start-up of the Safe2Tell program in 2003 with a three-year grant of \$375,000 and provided an additional three-year, \$375,000 grant in 2006. Safe2Tell also receives in-kind and financial support from the Colorado State Patrol and other local and statewide organizations.

ADDITIONAL EQUALITY IN HEALTH INITIATIVE GRANTEES NAMED

The Colorado Trust's \$13.1 million, seven-year (2005-2012) **Equality in Health Initiative** seeks to reduce racial and ethnic health disparities statewide. HEALTHY AGING INITIATIVE TO STRENGTHEN SERVICES TO SENIORS

By 2015, the state's senior population will grow by 47% to nearly 900,000 persons, and by 2030 one out of five people in the state will be 60 or older (Colorado Department of Social Services, Division on Adult Aging). The Colorado Trust has committed \$6.5 million to help 20 senior-serving organizations prepare to better serve this aging population.

NURSING TASK FORCE TO ADDRESS SHORTAGE AND STANDARDS

According to a 2006 report compiled by the Nurse Alliance of Colorado, a group organized by the Service Employees International Union, there are 3,600 hospital RN vacancies in Colorado. To help address this shortage, The Colorado Trust provided a \$35,000 grant to the Colorado Hospital Association's Center for Advancing Patient Safety under which the Nurse Workforce and Patient Care Task Force operates.

At the first meeting of the 14-member, governor-appointed task force on May 31 at The Colorado Trust, Governor Bill Ritter stated that additional goals of the group include examining the work environment for nurses statewide and helping consumers select hospitals.

The task force's recommendations are due to the governor and the General Assembly by December 31.

NEW CENTER ON IMMIGRANT INTEGRATION POLICY LAUNCHED

On April 26, The Colorado Trust hosted a Learning Lunch featuring leaders from the Washington, D.C.-based **Migration Policy Institute** (MPI) as part of the launch of its new National Center on Immigrant Integration Policy. An independent, nonprofit think tank dedicated to the study of the movement of people worldwide, MPI's new Center connects government agency administrators, researchers, community leaders, service providers, the media and others who seek to understand and respond to the challenges and opportunities of today's high rates of immigration.

Michael Fix, MPI Vice President and Director of Studies and Co-Director of the Center, presented current information on migration trends, challenges and best practices.

"While we have immigrant policies in the U.S., there are none for immigrant integration. Integration remains one of the most overlooked issues in national policy. It's high time to create a national think tank, website and clearinghouse for this purpose," he said. "The reason for more thoughtful immigration policy is not for charity, but – given increasing global competition – for the nation's economic self-interest."


NEW CARDIOVASCULAR & STROKE GUIDELINES

The Colorado Clinical Guidelines Coalition (CCGC) released its new Cardiovascular Disease and Stroke **Prevention Guideline** to help providers screen and manage patients who are at increased risk for cardiovascular disease and stroke.

Distributed to clinicians throughout the state, the guideline also helps doctors determine if a patient is low-, moderate- or high-risk for developing heart disease or stroke. In turn, doctors can better assist their patients by recommending lifestyle changes and other preventative measures.

As part of The Colorado Trust's **Improving the Quality of Patient Care Initiative**, CCGC seeks to improve health care in Colorado through the development and dissemination of evidence-based, best practice guidelines for pediatric and adult immunizations, cardiovascular disease and stroke disease.

COLORADO HEALTH INSTITUTE ANNOUNCES HEALTH CARE WORKFORCE WEBSITE

The Colorado Health Institute (CHI) – an independent and impartial information clearinghouse for state and local health data and resources – launched a new website on the state's health care workforce.

Part of CHI's **Health Professions Database**, the site provides data on Colorado's health care professionals in one location, including information about changes in the supply and demand of Colorado's primary health care workforce over time. Specific features include current workforce statistics; a new data section to find, view and compare information about Colorado statewide or any of its 64 counties; and separate data sections on the physician, nursing, oral health, mental health, pharmacy and allied health professions.

Additionally, the CHI website now includes a companion website on Colorado's health care **safety net**, including information on providers, users, and the workforce and financing of safety net efforts across the state and elsewhere.


