- [PEER Kindness](#) (Montrose County): An acronym for “Positive Encouraging Empathetic Respectful,” PEER Kindness is a nonprofit organization with a mission to work in partnership with schools, youth programs, community organizations, business and community leaders, families, and youth to reduce bullying and foster a PEER stance.

September 2016, Copper Mountain Resort:

- [TESSA](#) (Teller County): TESSA offers confidential support and services for victims of domestic violence or sexual assault and their children, including a 24-hour crisis line; a safe house that provides emergency shelter, food and services; victim advocacy, and much more. The funds will help them continue to operate their programs as well as expand staff to the Woodland Park area.
- [Chaffee County Oral Health Program](#) (Chaffee County): The program helps community members connect with free or low-cost dental services and providers, as well as transportation to and from dentistry care. The funds will be used to help educate communities—specifically through the use of *promotoras*—on varying fluoride levels in the water.
- [Rocky Mountain Rural Health](#) (Park County): Working to improve access to quality health care in Park County, Rocky Mountain Rural Health will use the funds to increase outreach and communication with community members; identify and address health- and health care-related issues; and support community initiatives designed to improve the physical and mental health of the people of Park County.
- [Custer 2020, Inc./Club America WMV](#) (Custer County): The funds will be used to support the mission of Custer 2020, Inc., which is to provide an accessible, multi-purpose activity center for the community, and enhance the health and quality of life for Custer County residents and visitors. Club America is a local fitness and community center that offers sliding-scale membership fees, as well as low- and no-cost community events.
- [Community Partnership Family Resource Center](#) (Teller County): The center provides programs and education for adult and parent enrichment; early childhood and youth; healthy living; and health care coverage. The funds will be used to support their ongoing programming and community meetings.

June 2016, Haxtun and Holyoke:

- Akron Balanced Child Development Center (Akron): The only child care facility in Akron, the center serves children from birth to age 12. The grant will help pay for the center's first computers, to be used primarily by older children.
- Bethel Community Center (Arriba): This is the only event space available for 40 miles in any direction, and is considered a vital community hub. The grant will help cover the cost of much-needed building renovations.
- [Melissa Memorial Hospital Foundation](#) (Holyoke): The grant will help strengthen the hospital's community outreach and development program to reach more Spanish-speaking households, and better support Holyoke's Latino population.
- [Prairie Family Center, Inc.](#) (Burlington): The center will use the funding to support their Healthier Living Program, a 16-week curriculum focused on self-management of chronic health issues, as well as physical and social/emotional health.
- [Rural Communities Resource Center](#) (Yuma): The grant will help support and expand the center's Estrellas program, which offers youth leadership development, opportunities and resources.

September 2015, Creede:

- Antonito Senior Citizens Association (Antonito): The association provides healthy meals, exercise and nutrition classes, regional field trips and ongoing social activities to local and home-bound seniors. The organization plans to use the funds to help provide legal support to seniors, as well as for general operating support.
- [Town of Saguache](#) (Saguache): The 500-resident town sits on the northern end of the San Luis Valley. The town plans to use the funds to spearhead a transportation survey for the town and surrounding area, to look at needs and possible solutions.

- [Move Mountains](#) (San Luis): Move Mountains empowers youth in San Luis and the surrounding area in civic engagement, community involvement and healthy living, including access to fresh food and outdoor activities. Programs include an after-school drop-in program, summer internships and leadership development. The organization plans to use the funds to buy gear and other supplies for youth outdoor activities.
- [San Luis Valley Behavioral Health Group](#) (San Luis Valley): Formerly known as the San Luis Valley Community Mental Health Center, the organization has provided behavioral health services in the San Luis Valley for 35 years. It plans to use the funds for outreach, training and client advocacy.
- [Sargent Early Learning Center](#) (Sargent/Monte Vista): The center provides a developmentally appropriate program for preschool children, and early Head Start all summer. It plans to use the funds to help install an air conditioner to support its summer programming.

June 2015, Rifle:

- [Reach Out Colorado](#) (Rifle, Parachute): “The ROC” provides emergency assistance to people in Rifle and Parachute, including food, rent payment, lodging, gas and transportation. It also provides healthy meals to children in Rifle at the end of the school week and during the summer. The ROC hopes to grow its network of volunteers to reach more community members.
- [SOS Outreach](#) (Eagle, Grand, La Plata, Lake, Routt and Summit counties): SOS Outreach serves at-risk youth using year-round, outdoor sports to engage underserved students in long-term mentor-based relationships. Its curriculum integrates outdoor experiential learning, character development, community service, values-based leadership development, social justice advocacy and peer mentoring. SOS Outreach served 4,569 youth during its 2013-14 program year.
- [The Family Learning Center](#) (Edwards): The center is dedicated to the healthy growth and development of all children, by providing continuing support from birth to age six. Its principles include universal access to high-quality child care, strong parental involvement and more. The Family Learning Center is the only Early Head Start child care provider in the Eagle Valley, and 78 percent of its students are considered low-income and receive financial aid in order to attend.
- [The Youth Foundation Parent Mentor Program](#) (Avon, Eagle Valley, Gypsum and June Creek elementary schools): The program gives parents the chance to be heard, gain education, become leaders, develop advocacy skills and build capacity to enrich the community. Parents of children enrolled in Eagle County Schools apply to become volunteers in a classroom at their child's elementary school. Last year, 24 parents graduated and 23 are returning to the schools this year, along with a new class of parent educators. They worked with more than 600 students, and hope to double that number over the next three years.
- [Ute Springs Experiential Learning Center](#) (Eagle County): USELC works with students ages 7-17 in every school in Eagle County. The center strives to bring increased self-awareness, social awareness, responsible decision-making and leadership skills to students while connecting them to the places they live through an adventure-based curriculum. USELC offers after-school programs, curriculum enrichment, a transition program for people with developmental disabilities ages 18-21, and a day and overnight summer camp program. Scholarships are available, and USELC hopes to expand its outreach in minority communities.

September 2014, Trinidad:

- Bent County/Las Animas Community Center (Bent County): to provide an after-school program for youth ages five to 18 in Las Animas.
- Crowley County Substance Abuse Coalition (Crowley County): to address drug and alcohol abuse by making presentations at schools and hiring counselors to continue educating youth on substance abuse.
- Fishers Peak Soup Kitchen (Las Animas County): to provide weekday meals, food baskets and meal delivery to area residents and cover vehicle maintenance and operating costs.
- Trinidad Community Farmers Market (Las Animas County): to provide access to affordable, healthy food options by expanding the market beyond summer months and providing outreach and education around fresh food.
- Two Peaks Fitness (Huerfano County): to assist individuals of all income levels in achieving fitness goals by subsidizing memberships for low-income members.

June 2014, Pagosa Springs:

- Archuleta County Veteran Services Office (Archuleta County): to assist veterans and their family members with Veterans Affairs benefits.
- Hospice of Montezuma (Montezuma and Dolores counties): to provide support for people with terminal illnesses.
- La Plata Family Centers Coalition (La Plata County): to create partnerships that strengthen families and improve community health.
- Southern Ute Indian Tribe (La Plata County): to provide diabetes treatment, diabetes prevention and healthy lifestyle education for Native Americans living on or near the Southern Ute Indian Reservation.
- TARA Historical Society at Navajo Lake (Archuleta County): to provide programs and services for the rural communities of Tiffany, Allison, Rosa and Arboles.

September 2013, Winter Park Resort:

- Community Agricultural Alliance (Routt County): to support availability of local foods to enhance healthy eating for all residents.
- Grand County Council on Aging (Grand County): to fund medical transportation to seniors and persons with disabilities.
- Reaching Everyone Preventing Suicide (Routt and Moffat counties): to support hospital-based suicide prevention, group therapy, crisis support and community education.
- Rocky Mountain Youth Corps (Routt County): to engage youth in the outdoors, teaching responsibility, teamwork and service.

June 2013, Ouray:

- All-American Families (Delta County): to fund mentors, community support and training to help children build a healthy future free from addiction, poverty, violence or trauma.
- The Center for Mental Health (Montrose County): to support day treatment for children with behavioral health issues living in extreme poverty; a peer-based program; and suicide prevention program.
- Confidential Advocacy Center (Gunnison and Hinsdale counties): to fund confidential safety needs and direct advocacy services for individuals whose lives have been affected by domestic violence and/or sexual assault.
- Grand Valley Catholic Outreach (Mesa County): to assist low-income seniors, mothers and children with access to over-the-counter medications.
- Haven House (Montrose and Delta counties): to provide shelter, support services and enrichment programs for homeless families and individuals.

- Chaffee County Public Health (Chaffee County): to support a nurse-home visitation program and workforce training for its Early Childhood Council's breastfeeding program.
- Custer County Community Sharing Center (Custer County): to help the food bank offer a larger quantity of food at a higher nutritional value.
- Full Circle Restorative Justice (Chaffee County): to provide alternative dispute resolution for high-risk youth by expanding their youth program, including education about compassion communication and alternatives to drugs and alcohol.
